

Oasis Shopping Village 'Roctober' Spend & Win Promotion 2019

Terms & Conditions

1. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is open to people aged 18 or over, visiting in person Oasis Shopping Village, Palmerston [The Promoter]. A \$15 minimum purchase is necessary to enter. Entries will not be accepted by post, email or any other medium.
3. Entries are limited to one entry for per purchase i.e. a \$15 spend or a \$250 spend in one transaction equates to one entry form.
4. The \$15 spend must be from one store to qualify. Cumulative spends from different retailers adding to \$15 will not be accepted.
5. There is no limit to the amount of times you can enter, provided you meet the criteria to receive an entry form each time you transact with an Oasis retailer.
6. Entries must be placed in the prize draw barrel provided. No other entries will be counted.
7. Entries must be made on original entry forms available at Oasis Shopping Village only. Photocopies, handwritten entries and other materials will not be accepted.
8. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and occupation) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process.
9. Employees of The Promoter, tenants of the Promoter and other entities associated with this Promotion, together with the immediate families and members of the household of those persons, are not eligible to enter. Immediate family means parents, siblings, spouse, children and grandparents.
10. The promotion will be open from 9am on Monday 7 October 2019 and will close at 5 pm on Friday 25 October 2019 [The Entry Period]. Entries will not be accepted outside of the entry period.
11. The draw will take place on Tuesday 29 October 2019 at 10 am, carried out by staff of The Promoter. The winner will be the first entry drawn from the barrel at random from all the valid entries.
12. The winner will be informed of their success by telephone if a number has been given. If they are unavailable, they will be contacted by post or email within 48 hours, provided that these contact details have been given on the entry form.
13. The winner can collect their prize from the Centre Manager's office of Oasis Shopping Village during the Centre's opening hours from Wednesday 30th October.

If, within 3 days of the draw, the winner cannot be contacted, there has been no response from the winner and/or they have not arranged to collect their prize from the Oasis Shopping Village, an alternative winner will be drawn. This draw will take place on Friday 2nd November at the same time and place and using the same method as the original draw.
15. The Oasis voucher prize is worth \$2,000 (two thousand Australian dollars). The prize will be presented in the form of 8 x \$250 gift cards, which can be used at any participating Oasis Shopping Village store. No change will be given by stores on individual vouchers, vouchers are not redeemable for cash and vouchers are to be treated as cash i.e can't be replaced if lost or stolen. These vouchers are also subject to the retailer voucher restrictions, if any.
